



MEMORANDUM OF AGREEMENT
between
The University of Iowa, Iowa City, Iowa, USA
and
The University of Rijeka, Rijeka, Croatia



In accordance with a mutual desire to promote further cooperation between The University of Iowa and The University of Rijeka, both institutions join in the following agreement on educational, training and research cooperation.

Cooperation in specific areas may be designated by mutual consent and incorporated as addenda to this agreement upon signature by appropriate representatives of the institutions. The details of cooperation for any of the identified fields may also be specified in the form of addenda to this agreement upon signature by appropriate representatives.

Within the fields of study to be mutually designated, both institutions agree to the following general forms of cooperation:

1. Joint educational, training and/or research activities.
2. Exchange of invitations to scholars (faculty, research personnel, and graduate students) for lectures, visits and sharing of experiences.
3. Exchange of invitations to scholars for participation in conferences, symposia and seminars.
4. Exchange of information in fields of interest to both parties.
5. Exchange of faculty, research personnel, and graduate and undergraduate students for study and research.
6. Practical training in pre-identified or otherwise selected field sites.

Both parties agree that all financial agreements necessary to implement this agreement must be negotiated and will depend upon the availability of funds.

This agreement will become effective upon the date of signature by the representatives of the institutions and approval by appropriate authorities in their respective countries.

This agreement is valid for a period of three years from the effective date and may be renewed before the expiration date by agreement between the parties; such agreement to take the form of an addendum to this agreement.

It is the policy of The University of Iowa and The University of Rijeka to guarantee the basic rights of their students and faculty by entering into exchange agreements only with institutions whose selection procedures for participation are based solely on the level of ability and quality of performance of candidates. The University of Iowa and The University of Rijeka reserve the right to terminate this agreement at any time if violations of this policy are brought to their attention and confirmed.

Both institutions subscribe to the policy of equal opportunity and do not discriminate on the basis of race, caste, sex, age, ethnicity, religion, or national origin. The University of Iowa and The University of Rijeka shall abide by these principles in the administration of this agreement, and neither institution shall impose criteria for exchanges of scholars or students which would violate the principles of nondiscrimination.






