

INSTRUCTIONS FOR UKRAINIAN STUDENTS IN ORDER TO OBTAIN FINANCIAL SUPPORT FOR THE STUDY MOBILITY AT THE UNIVERSITY OF RIJEKA WITHIN ERASMUS PROGRAM

On the basis of the Decision of Rector Prof. Snježana Prijić-Samaržija dated April 28, 2022, (CLASS: 990-01/22-04/01, REG. NO.: 2170-57-04-22-15) the study mobility of Ukrainian students at the University of Rijeka may be financed from the funds of current Erasmus KA131 projects.

Eligibility criteria for the mobility participants from Ukraine:

- Student status at the Ukrainian HE institution in the moment of escape from Ukraine due to Russian aggression.

Eligible activities:

- Student mobility for studies at the University of Rijeka
Note:
Student mobilities for traineeships shall not be financed!
The period of summer holidays shall not be financed, only the period directly spent on studies!
- In cases when sending institution cannot be involved in mobility activities due to war, the University of Rijeka shall organise the mobility by itself.

Application

- The participants initially apply to the University of Rijeka – HE institution where they intend to carry out the mobility. Applications/requests are sent to the following e-mail: international@uniri.hr.
- Interinstitutional agreement is not required.
- Nominations are not required.
- The University of Rijeka member institution checks the eligibility according to the documentation provided by the mobility participant.
- The examples of acceptable documentation proving the student status at the Ukrainian HE institution: confirmation of enrolment, transcript of records, declaration issued by the relevant Ukrainian HE institution or body.

Learning Agreement for Studies

- Learning Agreement for Studies is signed between the participant and the University of Rijeka member institution.

Financing

- The University of Rijeka shall provide financial support to Ukrainian students for the study mobility from the KA131 projects funds in accordance with applicable rates for incoming mobilities within KA171 for Ukraine.
- The University of Rijeka shall allocate financial support to students on the “first come first serve” basis, and after the student enrolls the University member institution and provides the proof of enrolment.
- The financial support may be given only for the study period at the University of Rijeka.
- The number of financial grants that will be provided by the University depends on available funds within Erasmus KA131 projects.

- Students and the University of Rijeka will sign the contract on financial support within Erasmus program, in accordance with instructions of the European Commission and Agency for mobility and EU programs, obtaining the Erasmus students status.
- Students shall have a right to receive top-up to individual support for individuals with fewer opportunities.
- If applicable, the participants may receive the inclusion support and travel support.
- Individual support for students amounts 1050 EUR per month (800 EUR basic grant + 250 EUR top-up for participants with fewer opportunities).
- If the student receives financial support for the study at the University of Rijeka within CEEPUS program, he/she cannot apply for the Erasmus financial support.
