



MEMORANDUM OF UNDERSTANDING

BETWEEN

L'INSTITUT D'ÉTUDES POLITIQUES [SCIENCES PO BORDEAUX], FRANCE

AND

UNIVERSITY OF RIJEKA, CROATIA

L'Institut d'Etudes Politiques, Sciences Po Bordeaux, France, (hereinafter called SPB) and University of Rijeka, Croatia, (hereinafter called UNIRI) establish hereby a formal understanding of cooperation and friendship which is intended to further the academic objectives of each institution and to promote better understanding between the faculty and students of SPB and the faculty and students of UNIRI. Under this Memorandum of Understanding, the two institutions will proceed to implement the following endeavours and exchanges of materials and personnel.

Areas of Cooperation

Assistance shall be carried out, subject to availability of funds and the approval of the competent authority of SPB and UNIRI, through such activities or programmes as:

- 1. Exchange of faculty members
- 2. Exchange of students
- 3. Joint research activities
- 4. Participation in seminars and academic meetings
- 5. Exchange of academic materials and other information
- 6. Special short-term academic programmes
- 7. Exchange of Administrative Managers/Coordinators
- 8. Joint cultural Programmes

The terms of such mutual assistance and necessary budget for each specific programme and activity that is implemented under the terms of this MoU shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular programme or activity and the terms of such programme shall be negotiated on an annual basis. Each institution will designate a Liaison Officer to develop and coordinate specific activities or programmes.

Scope of the Cooperation

The areas of cooperation include, subject to mutual consent, any Programme offered at either institution as felt desirable and feasible on either side and both sides feel contributes to the fostering and development of the cooperative relationships between the two Higher Education Institutions.

The assistance to be provided by each of the contracting parties will be teaching, research, exchange of faculty and students, and staff development, etc. as deemed beneficial by the two institutions.

Implementation

The Memorandum of Understanding (MoU) shall remain in force for a period of five years upon the date it is signed by the appropriate officials of the two institutions. It may be further extended or amended with the written agreement of both parties. This MoU may be terminated by either party subject to the delivery of six months' advance notice, in writing.

At SPB the International office will oversee the implementation of the MoU. At UNIRI the office of the International Cooperation will oversee the implementation of the MoU.

Both parties understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.
