conclude the following agreement.

The terms of the agreement are as follows:

### Article 1:

The two aforesaid Parties wish to establish cooperation and exchange in all academic areas of mutual interest, namely: education, research, administrative management.

### Article 2:

The purpose of this general Cooperation Agreement can include, but is not limited to the following activities:

- Exchange of research and teaching personnel,
- Exchange of students,
- Supervising exchange students during industrial training in factories,
- Academic and research programs,
- Double diploma program,
- Co-tutelle (joint Ph.D.) program,
- All administrative management tasks of mutual interest.

**Article 3:**

Each party appoints a Coordinator of the cooperation program.

Coordinator for the University of Rijeka is:

Vice Rector for Science and Arts, Prof. Gordan Jelenić, Ph.D.

Coordinator for the Silesian University of Technology is:

Vice Rector for Science and Development, Prof. Marek Pawełczyk, Ph.D.

**Article 4:**

Any specific activities, especially those involving, but not limited to, financial and other obligations, shall be the subject of mutual consent and approval of both Universities. The detailed terms of any such activity shall be discussed and agreed upon in writing, by the Deans/Official representatives of the cooperating faculties/institutions, and signed by the two aforesaid Coordinators of both Universities prior to the initiation of any particular program of activity, with reference to this general Cooperation Agreement.

**Article 5:**

This general Cooperation Agreement is concluded for an initial duration of five years and shall take immediate effect upon signature by the two Parties. Either Party may request changes to and/or cancellation of the general Cooperation Agreement by giving six months' prior notice. In that case, the actions in hand shall be brought to completion.

**Article 6:**

The Parties agree to place information about the agreement on their website and in promotional materials along with the permission to use the logo of the Partner.

**Article 7:**

The present agreement is made in English in two (2) copies, each copy being deemed authentic. Each partner institution shall receive one (1) copy.
