

INSTRUCTIONS FOR UKRAINIAN STUDENTS IN ORDER TO OBTAIN FINANCIAL SUPPORT FOR THE STUDY MOBILITY AT THE UNIVERSITY OF RIJEKA WITHIN ERASMUS PROGRAMME

Based on the decision of the Rector Prof. Snježana Prijić-Samaržija dated April 28, 2022 (CLASS: 990-01/22-04/01, REG. NO.: 2170-57-04-22-15), the study mobility of Ukrainian students at the University of Rijeka can be financed from the funds of ongoing Erasmus KA131 projects.

Eligibility criteria for the mobility participants from Ukraine:

- Student status at the Ukrainian HE institution at the time of escape from Ukraine due to Russian aggression.

Eligible Activities:

- Student mobility for studies at the University of Rijeka.
Annotation:
- Student mobilities for traineeships are not funded!
- The period of summer vacations is not financed, only the period directly dedicated to studies!
- In cases where the sending institution cannot participate in the mobility activities due to war, the University of Rijeka organises the mobility itself.

Application

- Participants first apply to the University of Rijeka - HE institution where they would like to carry out the mobility activity. Applications/inquiries should be sent to the following e-mail address: international@uniri.hr.
- Inter-institutional agreement is required (except in cases when Ukrainian HE institution is not working due to the war)
- Nominations are not required.
- The member institution of the University of Rijeka will assess eligibility based on the documentation submitted by the mobility participant.
- Examples of acceptable documentation proving student status at the Ukrainian HE institution include: certificate of enrollment, transcript of records, statement from the relevant Ukrainian HE institution or body.

Learning Agreement for Studies

- Learning Agreement for Studies is signed between the participant, the University of Rijeka member institution and authorised person at the Ukrainian HE institution (in cases when Ukrainian HE institution is not working due to the war, LA is signed only between the participant and the University of Rijeka member institution).

Funding

- The University of Rijeka provides financial support to Ukrainian students for study mobility from KA131 project funds in accordance with the applicable rates for incoming mobility within KA131 for Ukraine.
- The University of Rijeka awards financial support to students on a first-come, first-served basis after the student has enrolled at a member institution of the University and provided proof of enrolment.

- Financial support can only be awarded for the duration of the student's studies at the University of Rijeka.
- The number of financial grants awarded by the University of Rijeka depends on the available funds within the Erasmus KA131 projects.
- The students and the University of Rijeka sign the contract for financial support within the Erasmus programme in accordance with the instructions of the European Commission and the Agency for Mobility and EU Programmes, which gives them the status of an Erasmus student.
- Students have the right to receive a top-up of individual support for those with fewer opportunities.
- If necessary, participants can receive the inclusion support and the travel support.
- The individual support for students is 1050 EUR per month (800 EUR basic support + 250 EUR top-up for participants with fewer possibilities).
- If the student receives financial support for his/her studies at the University of Rijeka under the CEEPUS programme, he/she cannot apply for financial support under Erasmus.
