Zakonom o osiguravanju kvalitete u visokom obrazovanju i znanosti (NN br. 151/2022) (u daljnjem tekstu: Zakon) i dopisom Ministarstva znanosti, obrazovanja i mladih (KLASA:602-04/24-10/00004, URBROJ: 533-04-24-0001 od 8. siječnja 2024. godine) utvrđeno je da Središnji prijavni ured Agencije za znanost i visoko obrazovanje provodi postupak prijave za upis pristupnika na sva visoka učilišta i za sve vrste i razine studija u RH, uključujući i studije koji se izvode na engleskom jeziku. Sveučilište u Rijeci je postupilo u skladu s navedenom odredbom te je raspisan Natječaj Sveučilišta u Rijeci za upis na studije koji se izvode na engleskom jeziku u 2025./2026. ak. god. na način da se prijave za upise provode putem Središnjeg prijavnog ureda AZVO-a. ### GENERAL PART OF THE CALL

This call aims to inform prospective degree seeking students about the University of Rijeka's study programmes taught in English. It outlines the entry requirements, conditions and deadlines for application and enrolment in the 1st year of undergraduate, integrated (undergraduate and graduate), and graduate programmes for the 2025/2026 academic year.

By applying to this call, candidates acknowledge that the University of Rijeka and its faculties, as data controllers, will process their personal data solely for the purpose of organizing the selection process (including identification, competition registration, data verification, decision-making, re-registration, and publication of results). Applicants are also informed that their personal data will not be processed for any purpose other than those stated above and in compliance with relevant European and national data protection laws.

### BASIC INFORMATION ON THE PROGRAMMES

The University of Rijeka and its faculties offer the following programmes taught in English in the 2025/2026 academic year:

## ENTRY REQUIREMENTS AND SELECTION

Study programmes taught in English are open to Croatian and international candidates.

### UNDERGRADUATE AND INTEGRATED (UNDEGRADUATE AND GRADUATE) PROGRAMMES

Entry requirement: at least four-year high school education or its equivalent.

Candidates who completed their high school education in Croatia are required to take the state graduation exam. Applicants who completed their high school education abroad are generally not required to take it. However, some faculties may set minimum score requirements, including state graduation exam results, for certain programmes. In such cases, candidates can either take the required state graduation exams (in Croatian) or choose to be assessed based on their high school grades, special achievements, and any additional tests. Final exam results, if part of a high school education abroad, are considered equivalent to the Croatian state graduation exam.

Some degree programmes may have additional requirements, such as specific high school subjects, additional assessments, or demonstration of psychophysiological abilities relevant to the field of study. Those, as well as English language requirements, are outlined in the SPECIFIC PART of this Call and/or on the faculty websites.

## GRADUATE PROGRAMMES

Entry requirement: a degree at the undergraduate or integrated level or higher. In some cases, candidates with a vocational undergraduate degree may enrol after passing additional exams set by the faculty.

Some faculties may have specific admission requirements for certain graduate programmes, due to their specialized nature. These requirements may include completing a relevant undergraduate degree, a suitable lifelong learning programme, a specific number of ECTS credits, or other academic qualifications. Additionally, some faculties may require assessments of knowledge, skills, and competencies to ensure candidates are adequately prepared for successful study.

The specific enrolment and English language requirements for each graduate programme are outlined in the SPECIFIC PART of this Call and/or on the faculty websites.

## REGISTRATION AND APPLICATION

Candidates applying for enrolment to studies offered by the University of Rijeka must submit their applications through the relevant national application system, applicable to both Croatian and international applicants. It is essential to list the preferred study programme as the top priority. Changes to priorities can be made until the deadline specified in the Calendar section at <https://www.studij.hr/calendare>. Please note that there are separate calendars: one for undergraduate and integrated studies, and another for graduate studies.

**In certain cases, the application process is conducted at the faculty level in parallel with the national system, with distinct deadlines for submission**, to ensure the timely determination of a candidate's eligibility for admission to the selected study programme.

**Candidates are therefore strongly advised to carefully review the guidelines for each programme outlined in the SPECIFIC PART of this Call.**

Additionally, some faculties provide support and guidance for registration in the national application systems.

Details about the application and registration procedures to the national application systems is described below and in the SPECIFIC PART of the Call and/or faculty's websites.

## UNDERGRADUATE AND INTEGRATED (UNDEGRADUATE AND GRADUATE) PROGRAMMES

For undergraduate and integrated study programmes, candidates must apply through the National Information System for Application to Higher Education Institutions (NISaHEI/NISpVU) at [www.postani-student.hr](http://www.postani-student.hr). This system enables candidates to register for the state graduation exam in Croatia and apply for their preferred programmes.

After registering, the Central Admission Office will verify personal data of the candidates and notify the candidates once this process is complete. Once the personal data is verified, candidates have to log into the "Postani student" and select the faculty and the study programme they wish to enrol under *Moj odabir* (My choice).

The system allows applicants for undergraduate and integrated undergraduate and graduate studies to submit the **Request of a foreign high school educational qualification** (the last day for submission of the request is July 1, 2025). The request will appear on the personal profile of the candidates. The decision on recognition of a foreign high school education qualification will be directly delivered by the Agency for Science and Higher Education to the higher education institution for the purpose of enrolment.

Final deadline for registering for study programmes through the national application system is July 16, 2025, at 1:59 p.m.

## GRADUATE PROGRAMMES

Faculties offering graduate study programmes manage their own application processes independently of the national system. We strongly recommend carefully reviewing the instructions and deadlines for the desired programme in the SPECIFIC PART of this Call.

## PROCEDURE FOR THE RECOGNITION OF FOREIGN HIGHER EDUCATION QUALIFICATIONS

Recognition of prior educational qualifications for candidates who completed their high school education or undergraduate studies abroad, for the purpose of continuing education at Croatian higher education institutions, is an integral part of the enrolment procedure.

## UNDERGRADUATE AND INTEGRATED (UNDEGRADUATE AND GRADUATE) PROGRAMMES

Applicants to undergraduate and integrated study programmes who hold a foreign secondary school qualification submit a request for recognition of their educational qualification along with the necessary documents for the application procedure to the [Agency for Science and Higher Education](#). Detailed instructions, request forms and a list of supporting documents are available at <https://www.studij.hr/recognition>.

To initiate the recognition process, candidates must submit a Request for Recognition. This request can be submitted as soon as the candidate has registered on the website [www.postani-student.hr](http://www.postani-student.hr).

Candidates are advised to carefully follow the application steps outlined in the SPECIFIC PART of this Call to ensure timely submission of the Request for Recognition.

## GRADUATE PROGRAMMES

Prospective students who completed their undergraduate studies abroad must undergo a recognition process for their foreign higher education qualifications.

The procedure is managed by the [Academic Recognition Qualifications Office](#) of the University of Rijeka to which candidates must submit the Request for Recognition along with the required documents. The Request is submitted using the prescribed form available [HERE](#) (also found under the "Documents" section at <https://uniri.hr/en/studies/academic-recognition-of-foreign-higher-education-qualifications-office/>).

The completed application form with all necessary documentation in PDF format should be sent by e-mail to: [recognition@uniri.hr](mailto:recognition@uniri.hr).

**Note:** The Faculty of Humanities and Social Sciences (for the Master's in Cognitive Sciences - Cognition and the Mind) and the Faculty of Biotechnology and Drug Development (for the Biotechnology for the Life Sciences programme) will collect the required documentation from candidates as part of their application and selection procedures. They will then submit the Request for Recognition to the Academic Recognition Qualifications Office on behalf of the candidates.

The processing fee for academic recognition of foreign higher education qualifications is 60 EUR. Payment method is outlined [HERE](#).

## ENROLMENT

Enrolment in study programmes is managed by the respective faculties. Accepted candidates will enrol according to the procedures outlined in the SPECIFIC PART of this Call.

**Important note:** Accepted international candidates, whether through faculty admission or assigned an enrolment number in the national system (if applicable), must apply for a Croatian Personal Identification Number (PIN/OIB): [link](#). Some faculties provide assistance in obtaining the PIN.

## UNDERGRADUATE AND INTEGRATED (UNDEGRADUATE AND GRADUATE) PROGRAMMES

While some faculties select candidates through internal application processes, **all candidates for enrolment to undergraduate and integrated studies will also be ranked in the national application system**, granting them the right to enrol in the programme. **Each candidate will appear on the ranking list** in the national application system **only for the programme at the top of their priority list** and will be assigned an enrolment number. The candidate will be removed from the ranking lists of any other programmes.

Once assigned an enrolment number for a specific programme, candidates are required to enrol in that programme. Failure to do so may result in the higher education institution charging opportunity costs for the unfilled study place, potentially amounting to one academic year's tuition fee. To avoid such charges, **candidates must withdraw from any study programmes in the national application system they no longer intend to pursue, before the final rankings are published.**

Additionally, candidates should be aware that study programmes regulate their own payment policies, including amounts, deadlines, and non-refundable fees. Candidates are strongly advised to carefully review these regulations in the SPECIFIC PART of this Call to prevent any confusion or issues.

The ranking list in the national application system for undergraduate and integrated programmes will be published at <https://www.postani-student.hr/Ucenici/Prijava.aspx>.

Candidates ranked within the quota who receive an enrolment number on the final ranking list are eligible to enrol in their respective study programmes. Once the final ranking list is published, no further changes are possible. Therefore, candidates must regularly monitor their scores and notifications on [www.postani-student.hr](http://www.postani-student.hr).

Details regarding the enrolment process and deadlines are provided in the SPECIFIC PART of this Call. If candidates are selected through the internal application processes of the respective faculties, any relevant deadlines and responsibilities related to the centralised platform will be communicated by the faculty.

## GRADUATE PROGRAMMES

The enrolment process and deadlines for graduate study programmes are provided in the SPECIFIC PART of this Call.

## **TUTION FEE AND OTHER COSTS**

The tuition fee for each specific programme is detailed in the SPECIFIC PART of the Call. Candidates are responsible for covering all additional costs associated with the application and enrolment process for a particular degree programme. These may include fees for additional examinations, student insurance, and other related expenses. Payments must be made following the procedures and within the deadlines outlined in the SPECIFIC PART of the Call.

All students are required to pay an enrolment fee, which will be finalized prior to enrolment and is estimated to be approximately 50-60 euros.



## SPECIFIC PART OF THE CALL

The SPECIFIC PART of this Call provides detailed information on the conditions, deadlines for pre-application and application, the enrolment process, required documents for enrolment, tuition fees (including payment schedules), additional costs, entrance exams (including their organization and deadlines), and other important details related to specific study programmes.

Entry requirement: completed 4-year high school education programme or its equivalent. An IELTS 6.0 English proficiency level or CEFR B2 level is recommended.

- After logging in be sure you have selected our English-taught undergraduate study program with 180 ECTS, under the section "Moj Odabir".

## **University graduate study Business economics module: INTERNATIONAL BUSINESS**

Graduate study programs last two years – four semesters, and upon the completion of the program, students receive the academic title Master in Economics, univ. mag. oec.

**Entry requirement:** Academic undergraduate degree (BA/BSc) in the field of Economics or Business Economics (at least 180 ECTS credits). An English proficiency level IELTS 6.0 is recommended as a minimum. The grading procedure includes the evaluation of the success achieved at the university undergraduate study programme, i. e. the Distinction Programme:

- weighted average grade calculated to three decimal places
- if several candidates achieve the same weighted average grade, then preference will be given to the candidate who achieved a higher cumulative grade in the subjects: Microeconomics and Macroeconomics.

The grading threshold is determined by the enrollment quota.

The results of the grading procedure will be published in September after the completion of the application process on the Faculty's website [www.efri.uniri.hr](http://www.efri.uniri.hr).

### **Application process:**

First inform yourself about your application eligibility and costs (fees, deposits, health insurance costs, accommodation and subsistence costs etc.) at [international@efri.uniri.hr](mailto:international@efri.uniri.hr).

If eligible and ready to apply, submit your foreign bachelor diploma for **recognition** to the [Academic Recognition Qualifications Office](#) of the University of Rijeka (latest May/June).

**Admission procedure:** Applications for the admission procedure will be accepted until mid-September 2025, in accordance with the information published on the Faculty's website. Applications must be submitted by the specified deadline. Candidates must attach the documents listed in the Information on the Admission Procedure and Enrollment of Students in the First Year of Graduate Studies in the Academic Year 2025/2026 published on [www.efri.uniri.hr](http://www.efri.uniri.hr).

Enrollments after the 1st grading procedure will be held at the end of September 2025, according to the published schedule. ### **University graduate study BIOTECHNOLOGY FOR THE LIFE SCIENCES**

Study program “Biotechnology for the Life Sciences” is a graduate/masters research program, being run by the University of Rijeka, Faculty of Biotechnology and Drug Development. The program runs for two years (four semesters) and begins at the start of October each year.

The requirements for the course are completion<sup>1</sup> of an appropriate undergraduate degree course (minimum three years full time or equivalent), in which 60% of the content is in biology, chemistry and/or relevant subdisciplines (including, but not limited to, molecular biology, biochemistry, cell biology, microbiology or pharmacology). Students must have a strong command of the English language, which will be assessed at the interview.

Tuition fees for the course are 4500 EUR per year<sup>2</sup>.

#### **Applications**

Students interested should complete the “Application form for Biotechnology for the Life Sciences” and sent it to [life.sci@biotech.uniri.hr](mailto:life.sci@biotech.uniri.hr), along with copies of all the documents requested by this form. Applications must be submitted before midnight on **28th February 2025**.

Applicants from any country and of any citizenship may apply.

Applications will initially be assessed based on the applicant’s previous degree and grades, personal letter of motivation and letters of recommendation (see application form for details). The 20 eligible students whose applications are rated most highly will then be invited to interview (to be conducted by video conferencing software) which will focus on student motivation, basic knowledge of the field and English language skills. All applicants will be informed of the results of their applications, at the latest by 30th April 2025. For students doing undergraduate study in a Croatian institution, this recognition is not required, and so the deadline is extended to 23rd September 2025.

<sup>2</sup> By default, payment is due before the start of the academic year (October 1st) and is required to enrol. Students may also opt to pay in two instalments for year, with half due before each of the two academic years. In this case, the student must provide a promissory note, signed in the presence of a public notary, when paying the fee for the first semester.

<sup>3</sup> Students whose undergraduate studies were awarded by Croatian institutions are exempt from this.

<sup>4</sup> Under an incoming law, degrees from some Universities will be automatically recognised and therefore carry no fee. At the time of writing, we are waiting for confirmation of who this will apply to.

### **University undergraduate study Business Economics in Tourism and Hospitality module: HOSPITALITY MANAGEMENT**

#### **1. Entry requirements**

- Candidate who has completed a relevant secondary education program lasting at least four years and have passed the Croatian State Matura exam.
- Candidate who completed a relevant secondary education program lasting at least four years in the Republic of Croatia before 2010, without the requirement of passing the Croatian State “Matura” exam.
- Candidate who has completed an equivalent education abroad.

#### **2. Prerequisite for Enrolment – Motivational Interview**

The motivational interview in English language is a mandatory part of the selection process. The committee evaluates the applicants based on the interview. The motivational interview is an onsite or online discussion regarding the candidates' motivations and interest in the field of business economics in tourism and hospitality, with a special emphasis on hotel management. This may include professional goals, attitudes towards a specific area, or the desire for personal development of each candidate.

Depending on the outcome of the motivational interview, candidates who meet the requirements will be ranked on the official list for enrolment in the study program.

#### **3. For enrolment in the first year of study, the following criteria are evaluated:**

1. **Success achieved during secondary school** – up to 40%

3. **State competitions** – 5%

5. **Other special achievements** – 5%

The entry of results under numbers 1, 2, 3, and 4 into the NISpVU system (National Information System for Applications to Higher Education) is organized by the Central Admissions Office.

#### **4. State competitions in all disciplines are evaluated for enrolment in the first year of study.**

#### **5. The Faculty of Tourism and Hospitality Management evaluates other special achievements during the selection process, allowing candidates to earn additional points as follows:**

1. **Knowledge of a second foreign language** has evaluated if the candidate studied it for at least three years in secondary school or at a language school (minimum level A2). The following foreign languages are assessed: English, German, French, and Italian – 5%.
2. **Completion of another four-year secondary school** – 5%.
3. **International competitions** in the fields of economics, tourism, and hospitality – 5%.

Data regarding additional points from other special achievements assessed by the Faculty of **Tourism and Hospitality** Management are entered into the system by the Coordinator for the National Information System for Applications to the Faculty.

The Division of Cognitive Sciences at the Faculty of Humanities and Social Sciences, University of Rijeka is inviting applications to the graduate/Masters University study programme *Cognitive Sciences: Cognition and the Mind*. This is an interdisciplinary, research-focused 2-year MSc programme in cognitive sciences with a unique integration of psychology and philosophy, complemented by other disciplines within cognitive sciences. The entrance exam consists of a test in Biology, Chemistry and Physics (120 multiple-choice questions, with 40 questions from each subject).

Entrance exam will be organized on-site on Faculty of Dental Medicine on following dates:

- July 1, 2025
- September 2, 2025

The overall minimum score is 30%.

### Exemption from the entrance exam

- Applicants who have completed a premedical college or passed internationally recognized exams (MCAT – with a minimal score of 125 for each section) or earned a BA/Bsc degree in natural sciences with good credits in Biology, Physics, and Chemistry may be exempted from the entrance exam.
- Applicants who have taken the MediTest-EU (>70%) may also be exempted from the entrance exam.

### Psychomotor Ability Test

Psychomotor Ability Test is used for determining the precision, coordination, control, dexterity and reaction time of candidates.

Psychomotor Ability Test will be held online on following dates:

- July 2, 2025
- September 3, 2025

The preliminary results of the entrance exam and psychomotor ability test will be published on official website of Faculty of Dental Medicine.

**Important:**

High school certificates and graduation certificates published in a foreign language, must be accompanied by a translation of that same document into Croatian or English language validated by a certified court interpreter. Copies of documents must be certified by a public notary.

Validated copies of report cards in Serbian, Montenegrin or Bosnian Latin script, as well as those in English do not need to be translated by a certified court interpreter, but must only be validated by a public notary.

**The final score and ranking list**

The final score is composed of the secondary school grades (20%), Entrance exam scores (60%) and Psychomotor Ability Test scores (20%).

**Enrolment procedure**

When the final ranking list is published, candidates who are ranked within the quota and have received an enrolment number are eligible to enrol in the study program. Enrolment will be held online on following dates:

Summer term: July 22, 2025

Fall term: September 22, 2025

Enrolment is only valid for one academic year at a time.

Note: Students will be required to demonstrate knowledge of the Croatian language as specified in the study contract. They must achieve a B1 level of proficiency in Croatian by the time they enrol in their fourth year of study.

## **Joint YUFE Bachelor URBAN SUSTAINABILITY STUDIES**

The joint YUFE Bachelor's Programme in Urban Sustainability Studies, which was developed by the European university alliance YUFE (Young Universities for the Future of Europe), will equip students with interdisciplinary expertise in urban sustainability, fostering the ability to address local, regional, and global challenges through diverse methods and cultural perspectives. Graduates will be awarded a joint degree issued by seven European universities, positioning them as highly attractive candidates for both professional careers and advanced academic opportunities.

This degree programme offers an open curriculum with an innovative approach to studying at selected partner universities and includes at least two mobility periods (semesters).

### **Application process and deadlines**

Admission criteria:

- a secondary education degree
- and a minimum of B2 level in English.

The admission process for the YUFE USS at the University of Rijeka consists of **two selection rounds**. The first round serves as the primary admission phase, while the second round takes place only if there are remaining spots.

Each step of the procedure clearly outlines the deadlines for both selection rounds.

### **Step 1: Registration in the Virtual Campus**

Registration in the YUFE Virtual Campus is mandatory for application and serves as a prerequisite for admission consideration. Applicants must submit required documents and complete a short motivation questionnaire.

The application period for enrolment at UNIRI as a starting university runs from 3rd February to 10th July 2025.

### **Step 2: Document Submission**

All required documents must be uploaded to the Virtual Campus by the respective deadlines:

First-round deadline: 18th May 2025

Second-round deadline: 10th July 2025

### **Required Documents:**

**Secondary education degree:** A four-year high school diploma or equivalent, meeting university admission criteria in the country of graduation.

For applicants completing secondary education in 2025, a confirmation of study status should be provided.

Non-EEA applicants are encouraged to submit their diploma by 14th April 2025 to allow for qualification assessment by the Croatian Agency for Science and Higher Education.

### **Proof of English language proficiency:**

Level B2 or higher on the Common European Framework of Reference for Languages (CEFR), as stated in official educational records, or

A valid language certificate (issued within the past two years) with the following minimum scores:

TOEFL iBT (test centre only): 80

IELTS Academic: 6.5 overall, 6.0 per component

ITACE: B2

Cambridge English: B2 First (176 or above)

PTE Academic: 59

Alternative qualifications and equivalent scores may be considered.

Exemptions apply to those who:

Hold a diploma from an English-taught programme in Australia, Canada (English-speaking), Ireland, New Zealand, the UK, or the US.

Completed an English-taught programme elsewhere, with the language of instruction stated in official documents.

**Passport or identity card (for EU citizens):** A scanned copy of the relevant passport pages or an identity card (for EU citizens) is required to determine the enrolment quota category.

### **Motivation Questionnaire**

Applicants must complete a motivation questionnaire in the Virtual Campus, explaining their interest in the YUFE Joint Bachelor programme. Responses help assess suitability for this flexible, multi-university study format and may be used as a selection criterion for specific starting universities if necessary.

The questionnaire covers topics such as adaptability to new cultures, collaborative problem-solving experience, goals for the programme, and academic and career aspirations. Each response should not exceed 700 characters.

After the application is submitted, eligibility for the programme will be assessed. This includes verifying whether the application form is complete, all required documents have been provided, and the admission criteria are met.

If the eligibility requirements are fulfilled, an eligibility notice will be issued through the YUFE Virtual Campus:

First-round eligibility notice: 19th May 2025

Second-round eligibility notice: 11th July 2025

Receiving an eligibility notice does not indicate acceptance into the programme but confirms that the eligibility criteria have been met, allowing the admission process to proceed to the next steps, which may include selection.

### **Selection**

The maximum number of students admitted to USS at UNIRI for the 2025/2026 academic year is 20. If the number of applicants exceeds the available spots, a selection process will be conducted based on the evaluation of motivation questionnaire responses, following pre-established guidelines to ensure fairness and transparency.

Applicants who are not selected will be referred to other YUFE universities listed as priority choices. A second selection round will only take place if spots remain unfilled.

Selected candidates will receive an admission notification via email:

First-round admission notification: 27th May 2025

Second-round admission notification: 15th July 2025

Confirmation of enrolment at the University of Rijeka will be required to proceed with the enrolment process.

For applicants who completed secondary education abroad, diploma recognition in Croatia is required. The Croatian Agency for Science and Higher Education oversees this process, and UNIRI will submit the request on behalf of admitted students.

To proceed, additional forms and validated copies of required documents (high school report cards, graduation certificate/diploma, and proof of citizenship) must be sent by priority mail by:

First-round deadline: 18th June 2025

Second-round deadline: 17th July 2025

All documents must be notarized, and non-EU applicants must provide certified translations into Croatian or English. Detailed instructions will be included in the admission notification.

Important for non-EEA students: Due to the late enrolment period and the proximity of the semester start, participation in the second-round selection is not recommended for non-EEA applicants. The late issuance of enrolment confirmation could significantly delay the visa application process.

### **Enrolment**

At the conclusion of the admission process, UNIRI will notify applicants via email regarding the outcome.

**The annual tuition fee** for the YUFE Bachelor's Programme in Urban Sustainability Studies at UNIRI is:

€2,500 for EEA students

€5,000 for non-EEA students

The enrolment fee for the 2025/2026 academic year will be set by UNIRI and is expected to be approximately €60. Both the tuition fee and enrolment fee must be paid annually throughout the duration of the programme.

### **Enrolment process**

Enrolment will take place online on the following dates:

First-round enrolment: 17th–18th July 2025

Second-round enrolment: 25th–26th August 2025

Upon enrolment, students will receive a confirmation of their student status, which is required for visa applications.
