MEMORANDUM OF UNDERSTANDING

Between

University of Rijeka, Croatia

And

University of Ulsan, Korea

This Memorandum of Understanding between the **University of Rijeka** (hereinafter: **UNIRI**), with headquarters at Trg braće Mažuranića 10, 51000 Rijeka, Croatia, and **University of Ulsan** (hereinafter: **UOU**), with headquarters at 93 Daehak-ro, Nam-gu, Ulsan 44610, Korea, collectively referred to as 'the Parties', is written in the spirit of promoting international friendship and understanding by stimulating and supporting international activities and projects with emphasis on internationalization of higher education.

To further pursue cooperation in areas of mutual interest in teaching and research, with a desire to strengthen mutual contact and contribute to increased international cooperation, the Parties enter into this Memorandum of Understanding (MoU). Based on principles of equality and reciprocity, this MoU is the basis for further cooperation between the two Parties and/or their constituents.

For the purposes of this Memorandum of Understanding (MoU), each Party shall be deemed to include its parent company (where applicable) and its subsidiaries or affiliated entities. Either Party may, where appropriate, carry out activities under this MoU through any such entity, provided that such participation is consistent with the objectives and scope of this MoU.

ARTICLE 1

This MoU represents a commitment by both Parties to initiate discussions, negotiation, and collaboration concerning the activities listed below. Both Parties affirm that the detailed cooperation model will be defined by subsequent specific agreements arising from mutual discussions. Potential programs and activities between the two Parties include, but are not limited to, the following items:

1. Exchange of faculty members,
2. Exchange of students,
3. Student and/or staff non-degree short-term visiting programs,
4. Exchange of information,
5. Joint seminars, workshops, and summer inter-school programs,
6. Other academic exchanges or collaborative activities as mutually agreed by both Parties and/or their respective constituents.

ARTICLE 2

This MoU serves only as a record of the Parties' intentions and does not constitute or create, and is not intended to constitute or create, obligations under domestic or international law and will not give rise to any legal process and will not be deemed to constitute or create legally and/or financially binding or enforceable obligations, expressed or implied.

ARTICLE 3

Both Parties agree to first attempt to resolve any differences arising from this MoU or concerning its interpretation, implementation, or application of any provisions amicably through mutual consultation or negotiation through diplomatic channels.

ARTICLE 4

To ensure the effective management of this MoU, each party will appoint a person to oversee its day-to-day implementation and monitor progress.

ARTICLE 5

Any party may terminate this MoU for convenience and at any time and for any reason by giving six (6) months' notice in writing to the other Party.

This MoU shall be effective for three (3) years from the date of signing and shall be subject to change, renewal, and termination by mutual consent.

ARTICLE 6

This MoU is drafted in English in two (2) identical copies, one (1) for each party.
